The owner must arrive and forthwith take up permanent residence in New Zealand for the first time and have the legal authority to do so i.e. residence visa. If the car is imported for his own personal use with no intention to sell or use it for hire for at least two years.</p>	<p>You must personally visit H M Customs to clear your Motor Vehicle. Upon arrival, Motor Vehicle will be required to be tested for certification to New Zealand Compliance Standards. 		<p>The owner must be prepared to give a written undertaking that if he sells or disposes of the vehicle within two years of the date of its importation, he will have to pay an amount equal to the G.S.T. which would otherwise be payable.</p> <p>RETURNING NEW ZEALANDERS may import subject to payment of GST on vehicle purchase price, ocean freight and in transit insurance premium.</p>	<p>resume permanent residence. To prevent the importer having to pay unnecessary and irrecoverable storage costs in the intervening period, Customs will release the goods, in the absence of the owner, to a nominee appointed by the owner, provided that the following requirements are met:</p> <p>A nominee (friend, relative, agent, etc.) of the owner must apply to Customs at the port in New Zealand where the goods or vehicle will arrive, to arrange for Customs clearance. The nominee will need to produce:</p> <ul style="list-style-type: none"> <li>• (a) documentary evidence of authority to act for the owner.</li> <li>• (b) documentary evidence to show that the owner is taking up permanent residence in New Zealand for the first time, or in the case of a returning resident, has been living abroad for not less than 21 months.</li> </ul> <p>The nominee will then be required to:</p> <ul style="list-style-type: none"> <li>• (a) complete a Customs sight entry and lodge it with customs.</li> <li>• (b) pay Customs a cash deposit equal to the full amount of Customs charges that would normally be payable on the vehicle or goods.</li> </ul> <p>When the owner arrives in New Zealand the deposit will be refunded provided all the conditions governing concessionary entry can be met at that time.</p>

Other prohibited items.			Certain types of weapons such as flick knives, swordsticks, knuckle-dusters, and any weapon designed or disguised to give the appearance of another article. Medicines using musk, or rhinoceros or tiger derivatives such as ground horn or bone. Cat skins or coats.
